DRIVING DIRECTIONS

From St. Paul / 35E:

- Head North on 35E towards Forest Lake.
- Exit at Hugo/Centerville exit (CR-14), go east (right) towards Hugo.
- Come to stoplight (Hwy-61), turn right.
- Go 0.5 miles to next stoplight (Hwy 8), turn left.
- Go approx. 7 miles to dirt road (140th St. N. and Isleton), turn left.
- Go approx. 2 miles to driveway (9610 140th St. N.) turn left.
- Proceed on driveway until you see barn.

From Wisconsin:

- Head west on I-94 towards St. Paul.
- Exit at CR-15/Manning Ave. (Exit 253). Turn right
- Go approx. 4.3 miles to MN-5 (Stillwater Blvd), turn right.
- Go 2.1 miles and merge onto MN-36 west via the ramp on left.
- Go 0.8 miles to stoplight and take right on to CR-15/Manning Ave.
- Continue North 6.5 miles to 122nd St. N. (CR-7). Take left.
- Go 1.3 miles to Keller Ave. (CR-57), turn right.
- Go approx. 2 miles to dirt road (140th St. N), turn left.
- Go 0.9 miles to driveway (9610 140th St. N.), turn right.
- Proceed on driveway until you see barn.
